(AMENDMENT TO PERMIT PARKING PROVISIONS) ORDER 202*

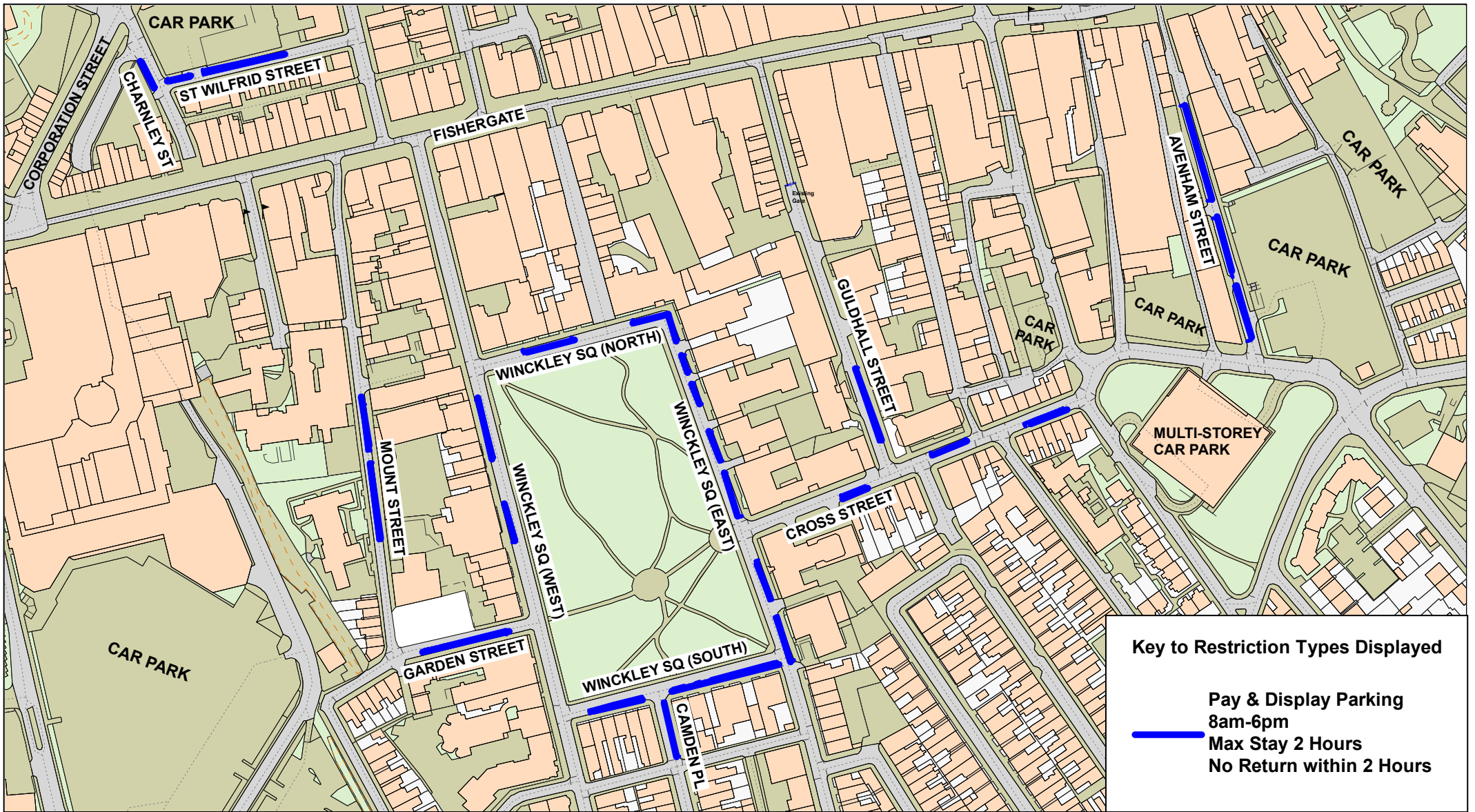
NOTICE IS HEREBY GIVEN that Lancashire County Council proposed to make the above Traffic Regulation Order under Sections 45 and 46 to the **Road Traffic Regulation Act 1984**, as amended. Following consultation carried out between 20 January 2023 and 17 February 2023, it is now intended to modify the proposed Order as titled above, as set out below.

Amend Schedule 13 to include a 2 hour tariff for Avenham Street, Camden Place, Charnley Street, Cross Street, Garden Street, Guildhall Street, Mount Street, St Wilfred Street, Winckley Square. The amendment will appear as shown below.
